DESCRIPTION

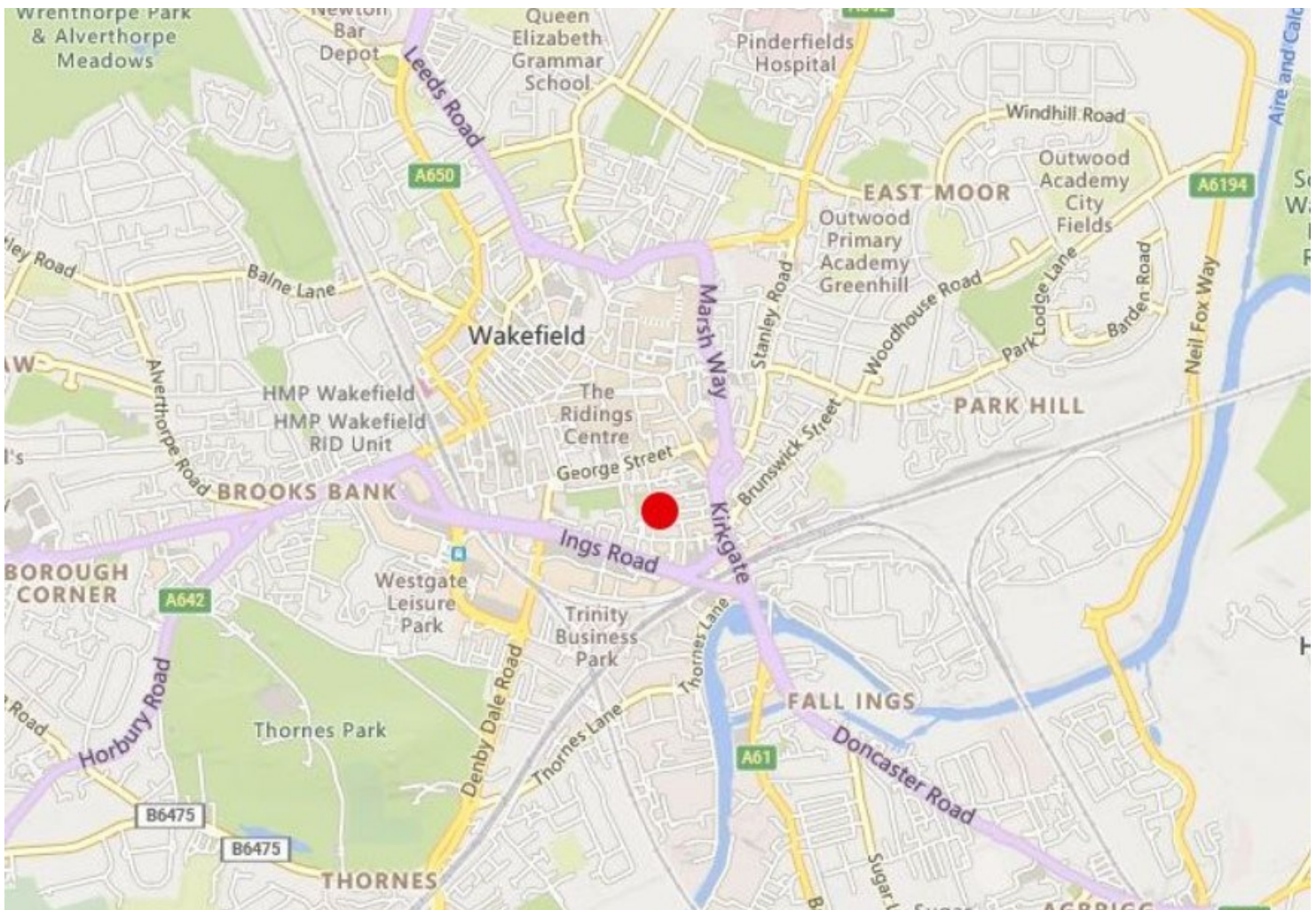
This is a well presented 3 storey property of traditional brick built construction. The accommodation being offered is on the second floor briefly comprising 4 offices with Wc facilities.

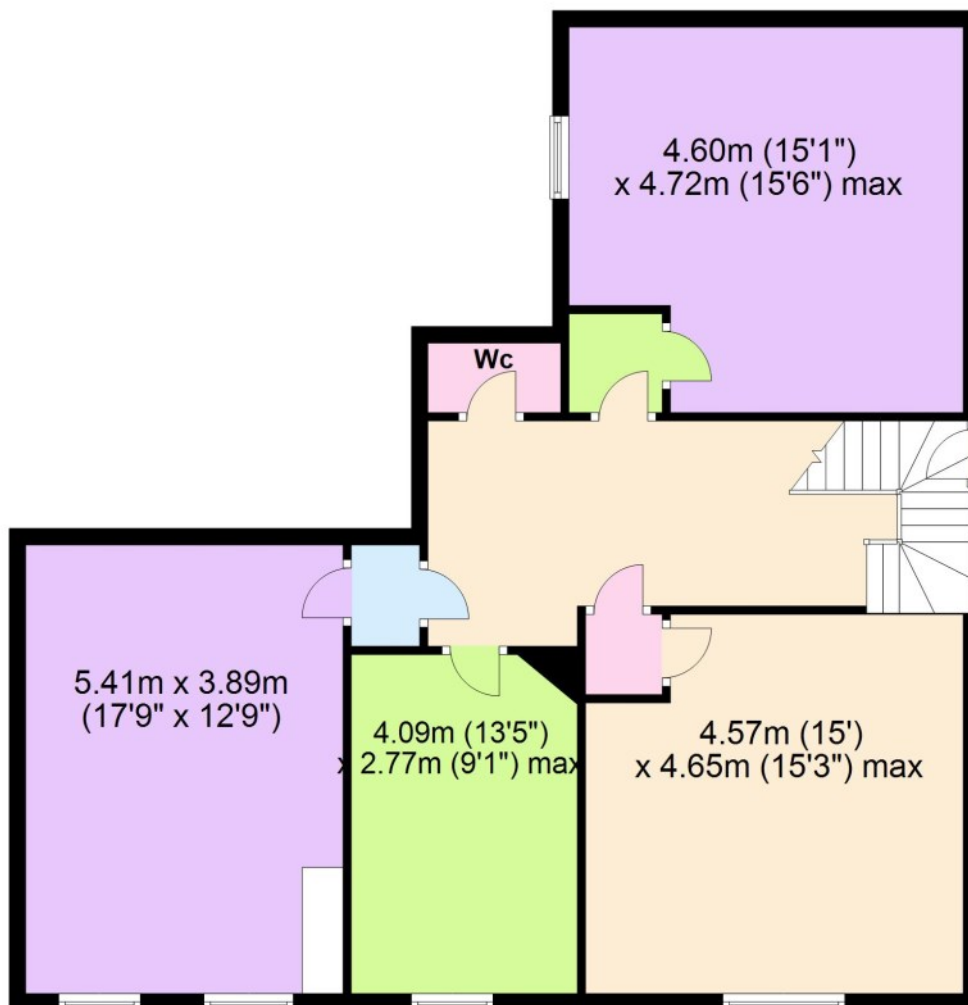
