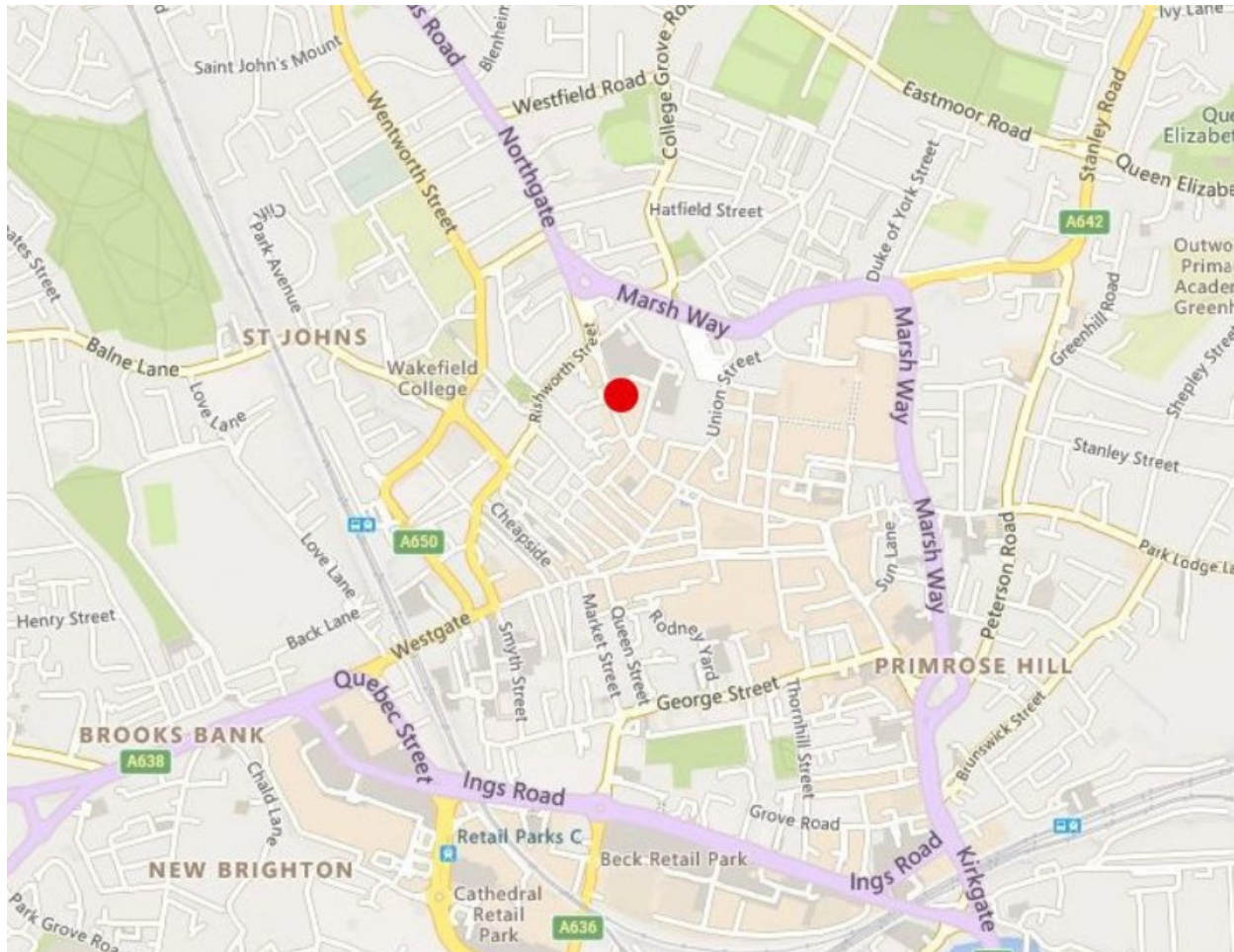
DESCRIPTION

This is a modern, well presented ground and first floor unit which was previously occupied by an aesthetics clinic. This property would suit a variety of users looking for a property on a main arterial route.

The accommodation at ground floor is broadly rectangular with partitioned reception and treatment rooms with a staircase to the rear. The first floor is also broadly open plan with a treatment room and benefits from kitchen and WC facilities.

LOCATION

The premises occupy a very visible trading location fronting onto Northgate. This part of the city centre is now considered a popular food hub with nearby traders including Fino Pizzeria & Cicchetti, Rustico's, Robatory and Sofra Turkish & Grill. This part of town is well served by both on street car parking and several large car parks, as well as the bus station all within a few minutes walk away.

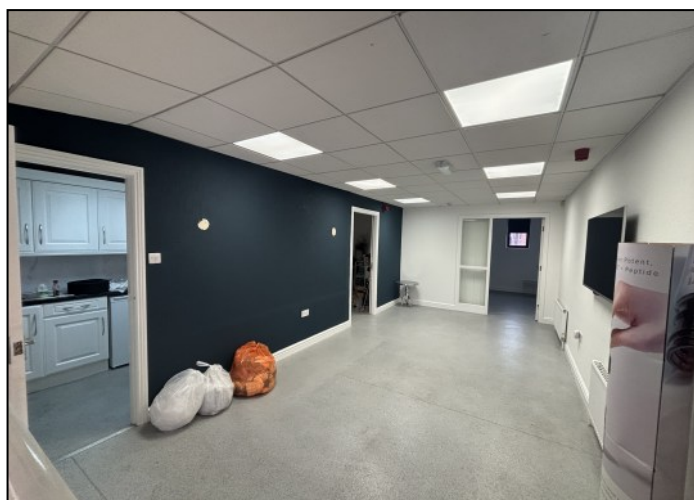
