This recently refurbished first floor space comprises of an open plan area, kitchenette and breakout space.

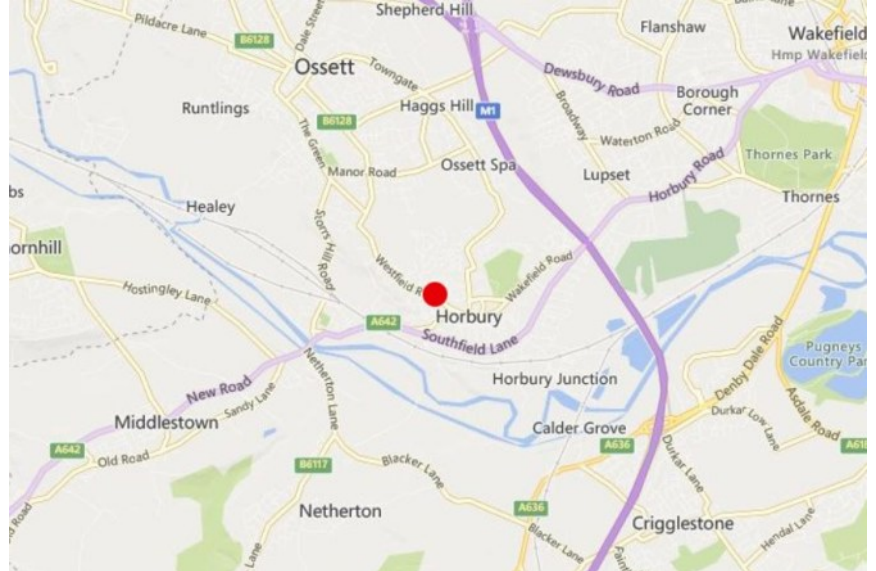
The accommodation could prove ideal for either a fitness studio or office space (the suite is currently fully furnished with 8 work stations. This could easily be removed to create an open space).
